Begins sunset of Monday, September 20
Ends nightfall of Monday, September 27
Yom Tov is observed September 21-22

★ **SHMINI ATZERET**
Begins sunset of Monday, September 27
Ends nightfall of Tuesday, September 28

★ **SIMCHAT TORAH**
Begins sunset of Tuesday, September 29
Ends nightfall of Wednesday, September 30

CHANUKAH
Begins sunset of Sunday, November 28
Ends nightfall of Monday, December 6

TU BISHVAT
Begins sunset of Sunday, January 16
Ends nightfall of Monday, January 17

PURIM
Begins sunset of Wednesday, March 16
Ends nightfall of Thursday, March 17
Occurs during Spring Break

D ★ PASSOVER
Begins sunset of Friday, April 15
Ends nightfall of Saturday, April 23
*Yom Tov is observed April 16-17 and 22-23
Only the first night of Passover is observed by the College*

YOM HASHOAH
Begins sunset of Wednesday, April 27
Ends nightfall of Thursday, April 28

★ **SHAVUOT**
Begins sunset of Saturday, June 4
Ends nightfall of Monday, June 6
Occurs after the semester ends this year due to Adar II

DICKINSON COLLEGE RELIGIOUS HOLIDAY POLICY

The college (offices and departments) will not schedule public and/or college-wide events on the following major religious holidays: Rosh HaShanah, Yom Kippur, the first night of Passover, Eid-al-Fitr, and Eid-al-Adha. The college calendar already excludes events on Christmas and Easter. Students must make arrangements with their faculty members in advance when an exam (including quizzes), papers, and other work are due on major religious holidays. A student will not be penalized for missing class or not handing in work on a holiday due to religious observance. However, students must notify faculty, in writing, reasonably in advance of the holiday if they will be absent from class for religious observance. Likewise, students who observe these holidays must notify, in advance, their coaches should they have athletic practice or scheduled competition at a time of religious observance. While faculty and staff are expected to be sensitive to the needs of observant students of all faiths when planning lectures, field trips, work and other curricular activity that might conflict with observance of a major religious holiday, any course work or other obligation that is missed remains the student's responsibility to complete. Faculty members are expected to make reasonable arrangements for students to complete missed work; students must make up the work. *For questions, contact Rabbi Marley Weiner.*
